
International Development

An African **organisation of people with disabilities** made a list of laws on disability in Africa.




Research looked at how laws in Asia and the Pacific include people with disabilities.

Women with disabilities find it harder to have an **abortion** and some are forced to use


contraception they don't want to use.

What do these words mean?




Abortion is when pregnancy is ended so that a baby is not born.

Living **independently** means being able to live without having to depend on anyone or anything else.





Organisations of people with disabilities have staff and members who are people with disabilities, who work on projects to help include everyone.




Research is about finding lots of information about a specific thing and bringing it all together.
